EXHIBITION SERVICES & GENERAL INFORMATION

- 2- THE FACIAS OF THE STANDS WILL BE PROVIDED ACCORDING TO THE SIZE OF AREA NEEDED BY THE PARTICIPANT COMPANY, WHICH IS MENTIONED ON THE APPLICATION FORM.
- 3- THE ORGANISER IS RESPONSIBLE FOR CLEANING THE PASSAGEWAYS & THE PUBLIC PLACES OF THE EXHIBITION, BUT THE EXHIBITORS ARE RESPONSIBLE FOR CLEARING THEIR OWN BOOTH(S).
- 4- EXHIBITORS ARE NOT ALLOWED TO DISCHARGE THEIR GOODS FROM THE EXHIBITION UNTIL THE DAY AFTER THE EXHIBITION CLOSING.
